MINUTES OF THE BOARD OF DIRECTORS MEETING

December 8, 2008

Call to order - President Richard Valdez calls meeting to order at 6:05 p.m. In attendance are Board members, Auntie Willie, Vice-President; Mark Wyatt, Treasurer; Mark Hinshaw, Clerk; Sahara Lawrence, Scribe; and Greybeard. Also, in attendance is community member Athena Peanut.

November Minutes - Minutes were read by Sahara. Richard motions to accept minutes, Mark H. seconds motion. Motion passes unanimously.

- 2. Ocean Park Meeting No meeting was held this past month. Richard & Mark W. spoke with an employee of Aloha Security. They are willing to give us a bid on "patroling" the park, if it deems necessary.
- **3. Holiday Dinner -** Willie offers to sell supplies (plates, warming pans, drink cups, etc.) to KSECA for \$50, a fraction of the original cost. Greybeard seconds. Passes unanimously.

4. Bulliten Board - Mark W. & Richard V. will construct a roof over the board by the mailboxes in hopes that this will better protect the board from the elements of wind and rain. We are exploring the idea of cork flooring as an alternative to the thin cork board that is currently on the board, which is not holding up at all.
