**C. Parks:**

**1. Pavilion Park Bathroom:**

**Motion:** by Gary, 2<sup>nd</sup> by Hazen to have a separate systems for each bathroom so both bathrooms are operating. One to be open and used and the second used as back up.

There is some concern about the possibility of a market on the upper west park this coming weekend. Currently we have no signs in that park. The board is wondering if there is a need for a park rules sign or other in that park.

Mark Hinshaw want to form a committee to repair the mailbox kiosk which is in extreme need of repair.
