C. Announcements- Stone announced a petition to the board with 97 member signatures, representing 160 lots. He asked to present it and gave it to Sage. Kelly made a motion to move up 7.D to the top of the agenda; no second; motion died. Stone presented Sage with a demand letter for a special meeting with 2 agenda items, as follows: recall and replacement of board directors; and termination of contract with Association Services. Jeranium asked that the statements read at the July meeting by Sage, Stone, and Jean be put in the July minutes.

2. Treasurer's Report Read by Jacob. Jacob read a long message about TMKs in arrears, how other subdivisions collect dues, etc. Total assets in savings \$. Total amount in arrears \$147,395.47. Laurie asked about the pay-it-forward effort to help those members who have difficulty paying their dues. Patti pointed out that Jacob's figures of dues collected during the board's 2015/16 collection effort of ~\$8600 was incorrect as one large landowner had paid all \$20,000 they had owed thereby bringing the amount collected closer to \$29,000. Ian pointed out that KSECA needs to be solvent to always avoid going into receivership.

Sage motioned to adjourn the meeting at 4:40 PM, seconded by Kekoa. 4 ayes, 1 nay (Kelly); motion passed.
